

## Kraków Live Festival Car Park for Audience Terms and Conditions

### 1. Lend and Lease Agreement

On receiving a Parking Ticket for August 16 or Parking Ticket for August 17 or entering the parking, a lend-lease agreement is established between Alter Art Festival Sp. z o.o with its registered office located in Warsaw, Kazimierzowska 14, entered in the register of companies by the 13th division of the District Court for the City of Warsaw under KRS number 227624, Tax identification number (NIP) 586-21-41-557 (hereinafter referred to as the Lessor) and the user (hereinafter referred to as the Lessee) - on the conditions contained hereinafter. The Agreement does not bind Lessor to supervise or to store the car. The lend-lease agreement of parking space expires on exiting the parking by Lessee. Lessee acknowledges and accepts the following terms of lease.

### 2. Parking fee, parking time

2.1. The parking fee for each occupied parking place is established in accordance with the current price list.

2.2. A pre-sale of parking tickets is conducted solely via electronic shop at [www.altersklep.pl](http://www.altersklep.pl). The number of parking tickets is limited due to the limited number of parking spots. The sale of parking tickets is open only until August 14, 2019 until 11:59 PM.

2.3. A Parking Ticket for August 16 entitles persons with ticket to the Event for a given day or an adequate festival wristband, to a single admission and exit during period from August 16, 2019 from 10:00 AM until August 17, 2019 until 9:00 AM. A Parking Ticket for August 17 entitles persons with ticket to the Event for a given day or an adequate festival wristband, to a single admission and exit during period from August 17, 2019 from 10:00 AM until August 18, 2019 until 9:00 AM. Leaving the Parking and entering it once again on the same day is impossible. If the car is left on the car park premises after the first day of the Event for the night (that means leaving the car until August 17, 2019 until 9:00 AM), it is automatically treated as a car which entered the car park again, which results in the obligation of purchasing another Parking Ticket.

Parking Ticket for the Lessee staying at the campsite entitles to one time admission and leaving the

car park.

2.4. After the maximum parking time expires on August 18, 2019 at 2:00 PM the Lessor is entitled to remove the vehicle at the expense of the Lessee. Moreover, until the vehicle is removed, the Lessor is entitled to remuneration in accordance with the price list.

2.5. If a parking ticket is lost, Lessee must pay a parking fee at least equal to the daily fee in the price list, unless Lessor proves that the parking time was longer.

### 3. Lien interest

On the basis of the claims resulting from this lend-lease agreement, Lessor has the right to keep the property and statutory lien interest on any parked vehicle belonging to Lessee.

### 4. Provisions on parking use

4.1. Vehicles shall be parked only in marked parking places and not in spaces marked as reserved with information signs or not intended for parking places. If the users do not comply with this obligation, the Lessor is entitled, at Lessor's discretion, to tow the vehicle away at the expense of Lessee or to charge a fee for occupying parking space in a way that does not comply with the Terms and Conditions. Lessor is entitled to block improperly parked cars by technical means.

4.2. The Lessor may refuse entry to parking to vehicles that are also advertisement or promotion carriers, or are breaching the binding law.

4.3. The Lessor is obliged to comply with the road signs and other conditions of using the car park and to comply with the orders of the car park staff.

4.4. it is forbidden to litter at the car park area or to devastate the equipment that can be found at the car park area.

4.5. It is forbidden to undertake any advertising, marketing or promotion in the parking area without prior consent of Lessor. Any persons breaching this prohibitions and their vehicles shall be removed from the parking.

4.6. Lessor prohibits campervans and vehicles with camping trailers from entering the parking area.

4.7. The Lessor or persons authorised by the Lessor, have the right to search through the vehicle in order to exclude the presence of such dangerous items as explosives, pyrotechnical materials, weapon or intoxicating substances which are forbidden by the Event terms and Conditions.

4.8. The Lessee is obliged to comply with the order commands of the Lessor or any persons authorised by the Lessor.

4.9. Persons violating the provisions of this Terms and Conditions and the vehicles belonging to those persons may be removed from the parking area by the Lessor.

#### 5. Safety provisions

5.1. The speed limit in the parking area is 10 km/h (6 mph).

5.2. It is forbidden to smoke, use open fires and perform engine trials or run engines with no purpose.

5.3. It is forbidden to wilfully park cars with leaking gas tanks or engines.

5.4. It is forbidden to stay in the parking area saved for parking purposes.

5.5. It is forbidden to repair or clean the interiors of vehicles, let out cooling water, fuel or oil in parking places, lanes, at the entrance and at the exit of the parking or on the parking roads..

5.6. It is forbidden to wash cars in the parking space.

6. In matters not regulated in these Terms and Conditions, the provisions of Civil Code and Traffic Code shall apply.
